WARMFIELD – CUM – HEATH PARISH COUNCIL EXTRACTS FROM THE MEETING HELD ON 21 MARCH 2012

<u>Community Centre</u> – It was agreed to make a full assessment of the financial position with the Community Centre at the next meeting. Cllr Gueli agreed to fix the outside security lights and investigate the performance of the new heaters.

A meeting is to be set up as soon as possible with WMDC, local residents and the Parish Council, to discuss the way forward for plans to upgrade the Children's Play Area.

<u>Public Participation</u> – Colin Aylward provided an update on the proposed Heath Common Transport Rally, to be held on 27 May 2012.

PCSO Katie Hestor introduced PC Collette Duffy, who is joining the Normanton NPT, which has recently won an award as the best NPT in the Wakefield area. They provided an update on recent activity in the Parish.

District Cllrs Blezard and Dagger provided information on the rotational grazing system for Heath Common and confirmed that the proposed day of action will take place in early April.

There were a number of Parishioners present who became involved in a long discussion on issues arising from the presence of the two Gypsy/Traveller sites within Warmfield. Cllr Fisher and District Cllr Dagger gave a full history of the illegal development at Boundary Lane, and recommended what action residents should now take. It was agreed that the Clerk should write to WMDC with regard to the problems caused by dogs belonging to the owners of the Marshall Hill site.

Clerk's Progress Report

- The Clerk provided an update on the proposal to install a Post Office branch in the Community Centre on one day per week. The requisite telegraph poles are now in place, and the installation of an ISDN line and a discreet power supply are now awaited.
- Following Email correspondence from WMDC Officers, a meeting will now be held to look at the provision of dog foul litter bin in Kirkthorpe Lane, Kirkthorpe.
- Cllr Vasey reported on the latest position with regard to Domestic Waste collection in the Half Moon Lane area.
- The Clerk confirmed that a response had been received from WMDC with regard to the report on various highway issues in the Parish. Work has been carried out in Goosehill Lane, and the issue of the illegal footway crossing has been addressed.
- The Clerk reported that contact had been made with the WMDC Empty Homes Officer. She confirmed that she was aware of the situation at the old school in Warmfield, but was not in a position to take up the matter at the present time.
- A letter of support for the proposal to set up a tea room in Heath has been sent.
