WARMFIELD – CUM – HEATH PARISH COUNCIL EXTRACTS FROM THE MEETING HELD ON 23 OCTOBER 2013

<u>Public Participation</u> – District Cllr Dagger confirmed his intention to follow up the issues around various Planning Enforcement issues which have been raised by the Parish Council. He also reported on the work being carried out by WMDC on a protocol for dealing with Gypsy/Traveller encampments. A final draft is awaited, and he promised to keep Members informed. The problems associated with untethered foals was discussed, and Cllr Dagger agreed to take the matter up.

Colin & Glyniss Wilson confirmed that the flyer being produced by the Warmfield-cum-Heath Fundraising Group was almost complete, and was due to be delivered to all households in the Parish before the end of the month. They also raised the need for a Parish Notice Board in Warmfield. The Clerk agreed to arrange as soon as possible.

PCSO Roxy Davison stated that she is to hold a drop-in session, in the Community Centre, on Tuesday 17 November 2013.

<u>Community Centre</u> – The Clerk confirmed that the Community Centre Account currently stands at £257.29. He also stated that the continuation of the Outreach Post Office was dependant upon it being used more, and he urged Parishioners to make more use of the facility.

<u>Clerk's Progress Report</u> – A number of issues were reported upon, as follows:

- Following a recent Review of Polling Stations, carried out by WMDC, it has been confirmed that there will be no change in this Parish.
- The Clerk reported on the information received from WMDC Planning Services on the various Planning Enforcement issues raised by Members.
- He also reported that appropriate trees have now been planted on the grassed area in Marshall Hill, Warmfield, as a deterrent to any future illegal camp sites.
- It was agreed that the Clerk should purchase a copy of the YLCA publication 'Local Councils Explained', which in particular sets out a copy of the new 'Model Standing Orders' for Local Authorities.
- An Email has been sent to WMDC Highways, asking for guidance on the practice of motor vehicles parking on highway grass verges.
- An Email has been received from WMDC Highways regarding the supply of Salt for 2013/14. It as agreed to request the full allocation of 2 Tonnes in small bags which will be distributed around the Parish.
- A request to place a commemorative bench on Heath Common was approved.

<u>Finance</u> – The Clerk provided a statement on the current financial position of the Parish Council, and presented appropriate Cheques for payment A letter from Littlejohns, the Council's External Auditor, approving the Accounts for 2012/13, had previously been circulated to Members. The Clerk also provided Members with an estimate of future expenditure up until 31 March 2014.
