6.Community Centre

Hs2 development event

The Clerk reported that contact has been made with Normanton Town Council regarding hosting an information event relating to Hs2, The Parish Council agreed that it would be beneficial to make contact with other Parish Councils in the affected areas and also to continue to liaise with Normanton Parish Council regarding this matter.
