#### 65/0516 PUBLIC CONSULTATION

District Cllr Dagger reported matters of concern that have been raised at previous meetings. Residents raised concerns regarding the work on the fish ponds at Willow Lane. The construction work that has been going on is to allow construction vehicles to enter the site while under construction. The Shop on Kirkthorpe is to be refurbished and will remain as a shop under the conditions of the lease. Consideration to be made to send a letter to WMDC supporting the shop remaining as a shop for the community. Both these matters are continuing to be monitored and the Parish Council will report any information as it is shared. Concerns were raised by Parish Councillors concerning the unauthorised access to the Common as bollards on the common have been broken. This is making the area target for fly tipping. Countryside admin to be informed.

Concerns were also raised regarding the horse numbers on the common. The organisers of the vintage car rally came to the meeting to request, a donation towards trophies for the event. It was agreed that the Parish Council would pay the rent to WMDC for use of the Common for the event.
