District Cllr Dagger reported matters of concern that have been raised at previous meetings. The Shop on Kirkthorpe is to be refurbished and will remain as a shop under the conditions of the lease. The clerk confirmed that a letter has be sent to WMDC to support the property remaining as a shop for the community.

Concerns that were raised by Parish Councillors at the last Parish Council meeting relating to the unauthorised access to the Common, Action to be carried out is that the entrance, is to be closed and a gate added with access being through the car park and the situation to be monitored.

They attended to discuss concerns of residents of young people hanging around the centre after the youth club has finished and also a further reported incident. Matters were discussed and solutions considered.
