**Public Consultation**

Speeding cars through Heath was discussed. The District Cllrs are looking into what can be done about this. Residents are reporting this to the police through 101 and logging it on My Account with Wakefield Council. The Clerk is going to invite the police to attend the next Parish Council meeting to discuss this issue. The Planning Application for the Battery Storage Site at Heath went before the Planning and Highways Committee last week and was rejected. This has already been sent to the Inspectorate. Heath Residents are going to defend this and are looking for contributions to the legal costs and asked if the Parish Council would be willing to help with these costs. The Parish Council will consider this and the Clerk will look into whether this is possible. The new candidate for the Labour party came to the meeting to introduce herself to the Parish Council.
